Scholarship of Academic Excellence

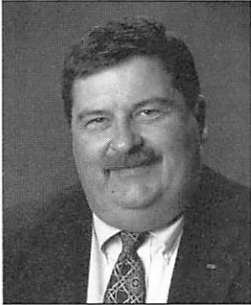
Awarded to academically deserving sons and daughters of active uniformed officers and firefighters.

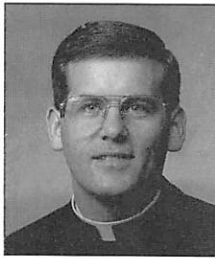

Rev. Dr. Christopher Hynes

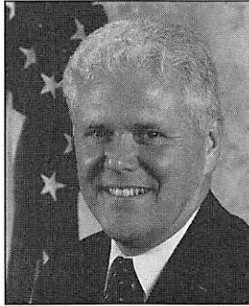
We welcome Father Christopher Hynes who has graciously agreed to serve as Chaplain for The Two Hundred Club of Union County.

Dr. Denis Onieal was appointed Superintendent of the National Fire Academy in Washington in July 1995.

He earned a Doctorate Degree in Education from New York University, a Master’s Degree in Public Administration from Fairleigh Dickinson University, and a Bachelor’s Degree in Fire Administration from Jersey City State College. He was a Professor in the Masters and Doctorate Degree Programs in Education at New York University prior to his appointment, and has over 20 publications in the field of firefighting.

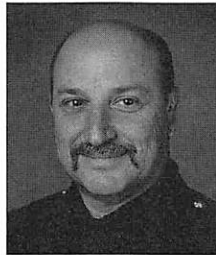
1998 VALOR AWARD RECIPIENTS



Firefighter Michael Young
Elizabeth Fire Department

On September 4, 1997 the Elizabeth Fire Department received an alarm of fire on Court St. Another multiple alarm fire already in progress caused a delay in the first arriving units.

Firefighter Michael Young, off-duty at the time, observed a smoke condition at the Court St. address and no apparatus yet on the scene. He proceeded to the front of the 2 1/2 story duplex. Firefighter Young saw a visible glow through the first floor windows with heavy smoke coming from the second floor windows. A civilian reported that two people were trapped upstairs. Firefighter Young attempted to enter the first floor but was driven back by fire and smoke. Firefighter Young obtained a civilian's ladder from a passing contractor's truck. Once on top of the ladder, which was less than 10 feet away from the fire venting out the front door, Firefighter Young opened the window and observed a woman inside. He tried to convince this woman to leave but she said "she would not leave until her mother was out." He climbed head first through the window and began a search. He found the woman's 71 year old mother on the floor unable to move. Firefighter Young then dragged the mother across the room and over to the window. He then climbed onto the ladder and leaning into the window lifted the woman up onto the ladder.

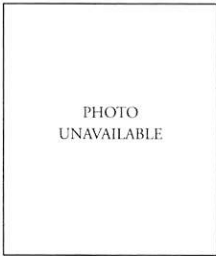

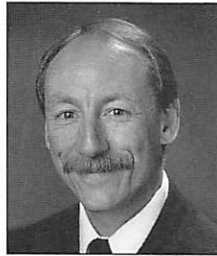
Firefighter Young, before descending the ladder, shouted to the other woman but received no reply and could not see her under the heavy smoke conditions. He was carrying the mother down as Officer Frank DePaola was climbing up a second ladder. Young told DePaola that there was another person still trapped. Firefighter Young brought the first victim to an arriving EMS unit. EMS began treating her for smoke inhalation.

Officer DePaola leaned into the window, despite heavy smoke and heat, and found the other woman lying on the floor near the window. Officer DePaola frantically struggled to remove her from the dwelling. Officer DePaola lifted the victim up and onto the window sill so that she could be brought down to safety. Officer DePaola was overcome by smoke after the rescue. Firefighter Mike Young and Officer Frank De Paola were both instrumental in saving the lives of the two women trapped in this fire. Their action was above and beyond the call of duty. Young while off duty risked his life for another, and DePaola, a police officer now receiving his second Union County Two Hundred Club Valor Award, performed a fire rescue at peril to his own life.

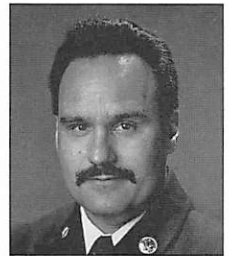

Dispatch advised the fire department that several victims were trapped in a single family structure in Rahway and that the police were on the scene but unable to effect rescue due to the extreme heat and smoke.

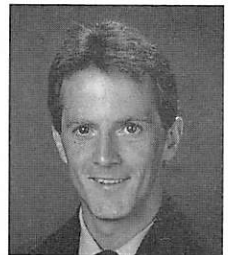
Upon arrival, it was again reported that three victims were on the second floor and one in the basement both by on-scene Police Department and one of the residents who escaped by jumping from a second floor window. Acting Captain Ronald Knox and Firefighter Michael Brothers, Engine #3 crew, were in the building. Captain Edward Taylor and Firefighter Richard Misita, Engine #7 crew, arrived moments later. After securing a feed line, they also aided in the search. Firefighter John Fleischman, Tower #1, secured a secondary means of escape by laddering the second floor then entered the structure to also aid in the rescue. Captain Daryl Rutter reported in from off duty and was sent into the structure to also effect rescue.

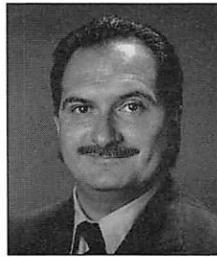

These individuals entered the structure without hose lines disregarding their own safety knowing full well there was a working fire in the rear of the dwelling. The extreme density of the smoke and heat of the fire were later found to be the result of arson with the use of gasoline. The firefighters removed one civilian from the stairwell and two from a rear bedroom closet. Lifesaving measures were performed on the rescued residents until the arrival of the Rahway First Aid Squad. Unfortunately 3 deaths occurred.

In attempting to save the residents in this tragic incident, the six firefighters showed extreme courage, presence of mind and total disregard for their own safety, the Two Hundred Club honors the courage of these six firefighters.

On September 4, 1997, the Elizabeth Fire Department responded to a call and upon arrival the first company responding observed a very heavy fire condition on the first and second floors.

Rescue 1 was the second on the scene, it was reported to them that someone was trapped inside. Firefighters began an aggressive interior attack utilizing a 1 3/4" hand line due to the high heat and heavy fire. At this time Firefighter Fanelli left the safety of the handline to perform a search. Firefighter Fanelli found a man unconscious on the bathroom floor. He dragged the victim to the rear door with the help of others. The victim was in respiratory cardiac arrest and had 3rd degree burns to his face and upper torso. Paramedics performed intubation and CPR on the victim. Above and beyond the call of duty Firefighter Fanelli without regard for his own personal safety deserves to be recognized for his valiant and professional action.
