# Education Grant Application

## For Police & Firefighters of Union County

The Two Hundred Club of Union County offers grants for undergraduate courses to police officers and firefighters on active duty in Union County, New Jersey. **The courses of study must be related to the professional improvement of the applicant in the areas of Criminal Justice or Fire Science. Grants are paid upon the successful completion of each course, and all requests for reimbursement MUST be received in our business office no later than 3 months following course completion – there are no exceptions.**

Any Two Hundred Club grant recipient who has successfully completed his or her prior semester studies, in the judgement of the scholarship committee of The Two Hundred Club, is eligible to apply for a renewal grant.

*The total award payable to any individual per year is limited by the Board of Trustees.  
The semester year runs from fall through summer and is limited to unreimbursed tuition costs only.*

The decisions of the Scholarship Committee shall be final and binding upon all applicants and any other interested parties. The information you give on this application, together with attached documents, is confidential and will be for use by the Scholarship Committee only.

**If you have not applied for other financial aid from your employer and such aid is available to you, you may be denied Two Hundred Club aid for this reason.**
